10. GENERAL BUSINESS

- 10.1. Debrief on Anzac Day Activities. The feedback from the public on the Dawn Service was most complementary. Discussion on potential for improvement centred on the need to improve the coverage of the sound system and streaming of the various activities during the service. It was a suggested the duration of the service be reduced. This may be achieved by improved coordination; the use of a running sheet and limiting school speakers 5 minutes in total. The President commended David Ferry and those who volunteered to support the School Visits program.
- 10.2. **Vivid Sydney Bus Trip**. Terry Saxby advised that the trip was fully subscribed but there may be a couple of vacancies due to medical issues with two members.
- 10.3. Date of June General Meeting. The Secretary advised our June meeting is due to be held on the King's Birthday long weekend and suggested it should be deferred to 17 June. The members agreed to change the date.
- 10.4. Monthly General Meeting. The Secretary mentioned that the sub Branch currently holds 11 General Meeting per year. Some of these meetings do not have significant agenda to warrant this frequency. The leadup of significant events such as Anzac Day, Remembrance Day and the AGM warrant General Meetings. It is proposed to use some planned meeting dates to hold social activities combined with presentations or events of interest to members and their families. The first of these activities will be on 8 July when we will hold a morning tea, followed by a presentation by Creightons Funerals and our usual snacks and refreshment. The meeting agreed to the change.
