### 8.1. Anzac Day

- a. I'm pleased to report on the success of our Anzac Day Dawn Service and the 11 am Service at Breakers. The Huey helicopter flyover at the Dawn Service was spectacular, and it was a pleasant surprise to many as it was a late inclusion in the ceremony. The 11 am Service included a flyover by a chipmunk aircraft on the dot at 11 am.
  - b. We are incredibly grateful to Peter Franks (National Helicopters), the pilot and owner of the Huey. He agreed to do this with short notice and free of charge.
  - c. Our ANZAC Day Breakfast at Breakers was very successful with over 90 people attending.
  - d. Thank you to everyone who attended school services and the volunteer members who manned the poppy sales desk. Our poppy sales exceeded expectation by generating approximately \$2500.
  - e. Once again, I thank all of our members who assisted in making this year's Anzac Day a great success.
