#### 8. PRESIDENT'S REPORT

8.1. Veteran's Health Day on Thursday, 6 October, was postponed because of unfavourable weather conditions. However, it was discussed and agreed at the Committee meeting to reschedule the event for Thursday, 3 November.

- 8.2. The RSL is one of the few not-for-profit organisations where members can be a beneficiary of its charitable purpose. However, there has been ambiguity around the definition of members. RSL State Branch recently circulated a draft Charitable Purpose SOP, which now includes affiliates in the definition of camaraderie when conducting social events and meetings. Our affiliates deserve this recognition as they do more than a fair share of the heavy lifting with sub-Branch activities.

However, our delegates are authorised to use their discretion and vote accordingly on each motion after hearing the supporting arguments.
- 10.2. DVA ISSUES. The President advised that DVA will now send digital copies of their correspondence to your myGOV account. Therefore, you will no longer receive letters from them in the mail. However, you can change your mail delivery preference in myGOV by accessing the 'Correspondence' button on the myServices homepage. On 31 May, 42,000 compensation claims were in the DVA system waiting to be processed. Let's hope there will be some relief included in the 25 October Commonwealth Budget.
