Scott Warr explained that the reduction will enable RSL NSW to provide each DC with a dedicated and paid Support Officer, which was part of the Strategic Plan. The recommendations of the steering committee will be presented to this year's Congress.
- 10.3. **Veterans' Health Week.** The Secretary advised the sub-Branch was successful in receiving a DVAS Health Week Grant of \$720 to support this year's Health Week activity. The theme of this year's activity is "Eat Well Nutrition". The activity will be held on 6 October as per the attached flyer that was made available at the meeting.
